



RECRUITMENT NOTICE

Semi-Conductor Laboratory (SCL) is a state-of-the-art R&D facility in the vital area of microelectronics. For its Dispensary within the campus it requires services of a Pharmacist 'A' in Pay Band-1 (5200-20200) + Grade Pay of Rs.2800/-. Applications are invited for the said post from persons meeting the following eligibility criteria :

- Qualification : First Class Diploma in Pharmacy.
Age Limit : Not more than 26 years as on 30.9.2009 (for SC/ST 31 years and 29 years for OBC candidates. Ex-serviceman and PWD are eligible for age relaxation as per Govt. of India Orders). **Govt. strives to have a workforce which reflects gender balance and women candidates are encouraged to apply.**

Last date of receipt of applications: Within 15 days from the date of publication of this notice.

Selection Process: A duly constituted Screening Committee shall screen the application received for the posts and organize a written test, if considered necessary for short listing the candidates for interview. SCL reserves the right to call for Test/Interview only those candidates who in its opinion are likely to be suitable and will not entertain any correspondence in this regard.

General conditions/instructions:

- i) Only Indian Nationals need to apply.
- ii) Candidates attending the interview will be reimbursed to and fro second sleeper class train fare by the shortest route from the address of the applicant given in the application to the place of interview.
- iii) At present the place of post is at SCL, SAS Nagar (Punjab), but the selected candidate is liable to be posted in any of the Units/Centres of DOS/ISRO situated anywhere in India as and when required.
- iv) Candidates working in the Central/State Govts., Public Sector Undertakings or Autonomous Organizations should apply through proper channel. In case they anticipate any delay in forwarding their applications, they may submit advance copies before the due date. However, the candidates are required to produce a No Objection Certificate at the time of interview.
- v) Exceptionally meritorious and deserving candidates may be considered for higher initial pay by the Competent Authority.
- vi) Candidates should enclose attested true copies of the relevant certificates/testimonials as proof of age, educational qualification, caste etc. alongwith the applications. Originals should be produced at the time of test and/or personal interview.
- vii) Incomplete applications received without the requisite information asked for in the prescribed format/without signature/without photograph pasted at the prescribed places/without attested to be true copies of all the certificates in support of their claim for educational qualifications, age, caste etc. are liable to be summarily rejected. Applications or enclosures thereof received separately after the due date for any reason whatsoever, will not be entertained by SCL. No correspondence in this regard will be entertained
- viii) Decision of SCL in all matters relating to eligibility, acceptance or rejection of applications, mode of selection, conduct of examination/interview will be final and binding on the candidates and no enquiry or correspondence will be entertained in this connection from any individual or agency on behalf of the candidate.
- ix) SCL reserves the right not to fill up the post, if it so decides.
- x) No interim correspondence will be entertained from the candidates who are not screened-in for written test/interview/appointment.
- xi) Canvassing in any form and/or bringing in any influence political or otherwise will be treated as a disqualification for the post.
- xii) Envelop containing Applications complete in all respects alongwith its enclosures properly tagged/stappled superscribing "Application for the post of Pharmacist 'A'", should reach the Sr. Admn. Officer (R&R) at the above given address within 15 days from the date of publication of the Recruitment Notice by 'ordinary post' only.
